As independent contractors, each musician shall personally be responsible for the payment of taxes, Social Security taxes, withholding of Federal Income taxes, or any taxes that he may be obligated to pay, as well as any Workmen's Compensation Insurance, or any other requirement of any independent contractor's responsibility and obligation by any Municipal, County, State or Federal law or regulation.

If at any time any musician shall become incapacitated or otherwise unavailable to render his services, the group leader shall replace musician with a musician of the same musical ability as the member who is unavailable, in the discretion of the leader.

The Purchaser in signing this contract, or having same signed by its representative, acknowledges its authority to do so, and hereby assumes liability for the wages agreed upon, payable according to the above terms, as required by the laws of the State of NC, and the laws of the United States of America.

In the event the Purchaser or the Musicians breach this agreement, either before or during the engagement, the party breaching this contract shall be responsible for damages sustained by the other, including reasonable attorneys fees, plus court costs.
