OUTSIDE STAGES MUST BE COVERED AND BE A MINIMUM SIZE OF 12 X 12. A VARIETY OF MUSIC WILL BE PLAYED, COVERS & ORIGINALS UNLESS SPECIFIED BY PURCHASER, AND MUSIC WILL BE PLAYED BETWEEN SETS IF REQUIRED.**

**BREAK AREA TO BE PROVIDED BY PURCHASER, ALONG WITH FOOD & DRINKS, SNACKS ETC. PURCHASER ASSUMES LIABILITY FOR MUSICIANS/PERFORMERS EQUIPMENT DURING ENGAGEMENT FROM LOAD IN, TO LOAD OUT.**

**THE LEADER AND EACH MUSICIAN/PERFORMER IS AN INDEPENDENT CONTRACTOR AND EACH MUSICIAN/PERFORMER SHALL PERSONALLY BE RESPONSIBLE FOR THE PAYMENT OF ALL TAXES, SOCIAL SECURITY TAXES, WITHHOLDING OF FEDERAL INCOME TAXES, OR ANY TAXES THAT HE OR SHE MAY BE OBLIGATED TO PAY, AS WELL AS ANY WORKMEN'S COMPENSATION INSURANCE, OR ANY OTHER REQUIREMENT OF ANY INDEPENDENT CONTRACTOR'S RESPONSIBILITY AND OBLIGATION BY ANY MUNICIPAL, COUNTY, STATE OR FEDERAL LAW OR REGULATION.**

**IF AT ANY TIME ANY MUSICIAN SHALL BECOME INCAPACITATED OR OTHERWISE UNAVAILABLE TO RENDER HIS OR HER SERVICES, THE GROUP LEADER SHALL REPLACE MUSICIAN/PERFORMER WITH A MUSICIAN/PERFORMER OF THE SAME MUSICAL ABILITY AS THE MEMBER WHO IS UNAVAILABLE, IN THE DISCRETION OF THE LEADER.**

**THE PURCHASER IN SIGNING THIS CONTRACT, OR HAVING SAME SIGNED BY IT'S REPRESENTATIVE, ACKNOWLEDGES IT'S AUTHORITY TO DO SO AND HEREBY ASSUMES LIABILITY FOR THE WAGES AND TERMS AGREED UPON, PAYABLE ACCORDING TO ALL THE ABOVE TERMS AND CONDITIONS, AS REQUIRED BY THE LAWS OF THE STATE OF NC, AND THE LAWS OF THE UNITED STATES OF AMERICA.**

**IN THE EVENT THE PURCHASER OR THE MUSICIANS/PERFORMERS BREACH THIS AGREEMENT, EITHER BEFORE OR DURING THE ENGAGEMENT, THE PARTY BREACHING THIS CONTRACT SHALL BE RESPONSIBLE FOR DAMAGES SUSTAINED BY THE OTHER, INCLUDING REASONABLE ATTORNEY'S FEES, PLUS COURT COSTS. IN THE EVENT OF CANCELLATION OF ENGAGEMENT DUE TO WEATHER OR UNFORESEEN CIRCUMSTANCES BY PURCHASER, THIS CONTRACT SHALL BE PAID IN FULL TO BAND.**
